

## AdageMail™ Subscription Agreement

This AdageMail™ Subscription Agreement (this “Agreement”) is entered into as of the date set forth below by and between ADAGE IT, INC., a California corporation, and the client set forth in the signature block below (“Client”).

1. **Subscription.** Client hereby subscribes for, and Adage IT agrees to provide to Client, the AdageMail™ antispam and antivirus email filter service (the “Service”), in accordance with the terms of this Agreement and the AdageMail™ Service Agreement. The subscription shall continue in perpetuity until terminated in accordance with the terms of the AdageMail™ Service Agreement. Client acknowledges the receipt of a copy of the current AdageMail™ Service Agreement.

2. **Mailboxes.** Client hereby subscribes for the number of mailboxes set forth in the signature block below. Upon written notice to Adage IT, Inc., Client may from time to time increase or decrease its number of mailboxes on the Service. Concurrent with the execution of this Agreement by Client, Client shall provide to Adage IT, Inc. a list of the email addresses that correspond to the mailboxes for which it has subscribed. Upon the request of Client (and the provision of any necessary administrative rights), Adage IT, Inc. will enable the listed email addresses on the Service. In the alternative, Adage IT, Inc. will consult with Client’s representatives to enable Client to effect the routing to the Service.

3. **Fees.** The set-up fee for each mailbox on the Service is Twenty Dollars (\$20.00), payable upon execution of this Agreement (or notice of addition of mailbox). The subscriber fee for the use of the Service is Five Dollars (\$5.00) per month per mailbox. For a subscription of ten or more mailboxes, the Service fee shall be payable monthly in advance on the first day of each calendar month. For a subscription of less than ten mailboxes, the Service fee shall be payable quarterly in advance on the first day of each calendar quarter. Service fees for the initial calendar month or calendar quarter are payable upon execution of this Agreement and shall be prorated for any partial initial period. Unless otherwise approved in writing by Adage IT, Inc., all fee payment shall be made in accordance with the AdageMail™ Service Agreement. 5. **Integration.** This Agreement and the AdageMail™ Service Agreement (the terms of which are incorporated herein and made a part hereof) constitute the entire agreement of the parties with regard to the subject matter set forth herein and therein, superseding all prior representations, warranties and agreements relating hereto, and may not be amended or modified except in a writing duly executed by each of the parties.
